Eligibility

If you earned income from part-time jobs or your parents/spouse, and you are suddenly facing financial difficulties because your income has reduced by 50 percent as compared with last year due to the spread of the COVID-19. (*Even though you repeat a year, or do not satisfy the "Academic Requirements", you will be eligible for exemption.)
